PROGRAM OVERVIEW

The Malaysia My Second Home (MM2H) Programme, initiated by the Government of Malaysia, aims to extend a warm invitation to global citizens seeking to establish their residence in Malaysia.

Approved participants receive a renewable multiple-entry social visit pass, with the privilege of including their spouse, unmarried children between 21 - 34 years old, applying for a maid, and sponsoring parents as dependents.
